FUNDING

Two types of funding

- 1. Appropriated funds (APF)
- ☐ To pay or offset the cost of recreation programs and services
- ☐ CY2024 funding avg. is ~\$13.50 pp
- 2. Nonappropriated funds (NAF)
- ☐ To purchase food and beverages in support of Unite programs
- ☐ CY2024 funding avg. is ~\$5.00 pp

Unite funds can be used...

- ➤ to offset recreation programs/services costs
- to rent recreational equipment in support of a unit cohesive event
- for Decorations
- > for Program Supplies
- ➤ for Entertainment/Events
- for Food and Beverages (non-alcohol)

Unite funds cannot be used...

- ➤ for taxes, tips, gratuity, or transportation
- ➤ to purchase alcoholic beverages or for/in conjunction with holiday parties, end of year events, balls, banquets, dining in/out, change of commands, training/meetings, promotions/retirements, and base-wide special events
- to purchase equipment, prizes, vouchers, gift cards, giveaways or promotional items (ex: trophies, medals, plaques, banners, marketing/ advertisements, apparel, cups, etc.).
- ➤ for gambling, or to purchase gambling products. This includes traditional bingo...
- AFSVC will not provide reimbursement to events that have not been approved by them. If a squadron executes an event without approval, all expenses will be the responsibility of the squadron.
